



## Terms of use

These terms of use entail the general terms related to the use of websites and services thereof (later "sites and services") maintained by the Student Village Foundation of Turku (later "TYS") at the address [www.tys.fi](http://www.tys.fi), which the user commits to comply with by using the sites and services.

TYS has the right to change, at any time, the content of the sites and services and their availability or to cease publishing the sites and offering the services therein either temporarily or definitively. TYS also has the right, at any time, to change these terms of use.

## Intellectual property rights

All material published on the sites and services is property of TYS protected by trademark law, copyright and/or other intellectual property rights, with the exception of services provided by third parties and possibly attached to the sites, such as map services. TYS reserves all rights to the material published on the sites and services therein.

The material published on the sites and services may be browsed and copied by printing or by downloading on a computer. However, the materials may only be used for non-commercial and personal purposes. Copies or parts thereof may not be sold or shared electronically or as paper copies for commercial purposes, nor may they be altered or attached to other materials or websites. Press releases may be published in media, provided that the reference is mentioned.

TYS strives to ensure the availability of the sites and services and their uninterrupted and flawless use, as well as to ensure that any materials and information therein are up-to-date and correct. ## Processing of personal data (data protection)
